Purchaser has previously paid a non-refundable deposit of \$_____ to the Breeder to reserve the Kitten for the Purchaser. This deposit has been applied towards the purchase price. Any balance owing is due and payable the day before the kitten is collected.

TERMS AND CONDITIONS

This kitten is guaranteed to be of good health at the time of sale. This kitten is guaranteed to be healthy and free of disease at the time of leaving Jemstones Bengals Cattery (unless otherwise indicated and agreed on by Buyer and Breeder).

Stress related health conditions are not part of this health guarantee and will not be covered. It is often common for a kitten to experience loose stool due to stress in transitioning to a new home. This will pass within a few days to a week. Your kitten has been thoroughly examined twice by a certified veterinarian and found to be in excellent health both times.

This kitten must remain quarantined from all other pets for a minimum period of 2 -3 days. If any illness occurs during the first 72 hours, the breeder must be notified immediately.

The buyer agrees to take good care of this kitten and provide food, shelter, suitable healthy and stimulating environment, correct routine, accident related medical attention, exercise and tons of affection.

It is agreed that this cat will not be allowed outside without supervision. If the cat is allowed to roam outside freely without supervision then all health guarantees included in this pet agreement are void.

This animal is a purebred Bengal Cat and the 5 generation pedigree provided is correct for the same. We are an established TICA registered Cattery operating under the name of Jemstones.

This kitten is guaranteed to be free from congenital defects, HCM and genetic disease for a period of 1 year from the date of sale (date of sale is considered the date that the kitten leaves our cattery)

In the event that this cat is found to have a congenital defect/disease or HCM and substantiated with proof by a licensed veterinarian and cardiologist and verified with the breeders own veterinarian, the following options are:

- a) It can be returned to the breeder for a replacement of equal quality, buyer is responsible for all shipping fees (both ways) and parasite, FIV/FelV testing.
- b) It can be kept by the owner, and a rebate of 50% of the purchase price will be credited towards another kitten of the same quality.

IF FOR ANY REASON, THE BUYER IS UNABLE TO RETAIN OWNERSHIP OF THE KITTEN, THE BREEDER REQUESTS NOTIFICATION, AND THE KITTEN MUST BE RETURNED TO THE BREEDER.

UNDER NO CIRCUMSTANCES IS THIS KITTEN TO BE RESOLD OR GIVEN TO A SHELTER OR SIMILAR FACILITY.

By initialing the below terms, buyer agrees to THE FOLLOWING:

_____ Breeder is not liable for any contagious illness (FELV, FIV, Rhino, etc) once the kitten leaves this cattery, if not present on take home date of kitten.

_____ Breeder recommends the kitten be annually vaccinated with an inactivated vaccine of FEL-O-Vax PCT + Calici Vax. Breeder is not liable or responsible for any sickness or side affects caused by the kitten receiving a live or modified live vaccine.

_____Breeder recommends the kitten **not** be vaccinated for FIP, FIV/Felv. Vaccination of FIV will cause a cat to test positive.

_____ The breeder is unable to guarantee there will be no changes of colour, contrast, pattern, features or size of the above said kitten.
